#### About us

AdarshSevaSansthan (ASES) came into existence in 1987 in Jamshedpur's brick kiln areas for ensuring education of children.Brick kiln settlements were established by migrant workers on the banks of the river 'Swarnrekha' and 'Kharkai'. Slums in Jamshedpur (Jharkhand) are situated on the periphery of the planned city. Although hutments are now semi-permanent, there is no recognition of these residents in larger urban development planning programs.

ASES started operation for the development of slum children as most of the children were malnourished, suffer health problem due to environmental changes and didn't attend school. In order to educate the slum children, ASES started working in slums by starting Non Formal Education School (NFES) comprising of 45 children in NTT basti, Jamshedpur. Gradually NFES in nearby bastifollowed. The year 1995-96 was a turning point for the workers as the lease of the brick kiln factories expired and was not renewed owing to environmental concerns. As a result the brick kiln factories were closed. The migrated workers however continued to live in these settlements which are currently situated in different parts of Jamshedpur which is part of the TATA Lease Agreement.

Children, Men and Women are empowered through BalSangathan (Children Collectives), JointBasti Committee (Community Based Organization) and MahilaMandal (SHGs) which is Strength of ASES. ASES's welfare initiatives address core issues on Human Right, Child rights, Women's empowerment, Environment, Education, Crèche (Palnaghar), Livelihood and Advocacy

CRY addresses children's critical needs by working with parents, teachers, Anganwadi workers, communities, district and state- level governments, as well as the children, themselves. The organization focuses on changing behaviours and practices at the grassroots level and influencing public policy at a systemic level, thus creating an ecosystem where children are the nation's priority.

### CAPACITY BUILDING OF BAL SANGHATHAN

#### LIFE SKILL TRAINING -



In order to recognize herself and give certain direction to full fill small dreams of life and achieving goal of the life 12 life skill training organized with girls on "Super Smart Shakti" Module. Total 215 girls were participated in the training. To create sensitivity among adolescent boys for creative contribution towards the community and find his own Identity (Asli Mard) 12 life skill training organized with them. Total 186 boys participated in this life skill training.

### TRAINING ON PSYCHO-SOCIAL WELL BEING-

Due to COVID-19 Pandemic, the Socio-Economic condition was worst affected. The Children were also victim of the situation. Education system had collapsed. On line classes were beyond the reach of the poor children. The "Psychosocial Well Being" program was worked out on a specific "Module". It was specifically designed to improve psychosocial status of the children. In 07 sessions total 107 (41M, 65F) participants took active part.



# COVID-19 MODULE—

15 weeks Psycho social well being modules were introduced by CRY for Bal Sagathan Members, which includes "Challo Vayam Karen", "Hamari Prasansha Suchi", "Anubhav Prapt karna", "Challo Khajana Khoje" and "Ek Kitab Pare" etc. As due to Covid children were faced mental pressure. Bal Sagathan leaders took responsibility of conducting and facilitating these modules. Modules contained were sending through whats up group every day and children everyday eagerly waited for modules. 142 participants (36M, 142F) in 15 what's app group of



all III cluster. This exercise was successful to remove social stigma of the children.

# **WORKSHOP ON MEDIA LITERACY AND DIGITAL SAFETY**

One day workshop organized at Adarsh Seva Sansthan on media literacy and Digital safety, as with the outburst of COVID epidemic all school & colleges were closed and children used online platform for their education. In order to save them from cyber crime the children need the required knowledge on digital safety. Children gained knowledge on what is Cyber Crime and how to keep themselves away from it, difference between Information and News, Clarify Authenticity and truth of the News and How to use Twitter, Whatsapp, and Instagram. In this workshop total 54(12M, 42F) Bal Sangatha Leaders participated and learn about the topics.

### CELEBRATION OF DAY AGAINST CHILD LABOUR-

On 12<sup>th</sup> of June-- A Day against Child Labour was celebrated. **Wall writing Campaign** was being carried out by the children of Bal Sangathan. The children had completed "Wall Writing" on **120** walls. There were **20 children** participated in this campaign.





#### SAMMAN SAMAROH-

Children were being **felicitated** for their outstanding work especially COVID-19 PERIOD in distribution of Mask, Sanitizer, Dry Ration, Milk and Biscuit to the children and others toward the community. In order to recognize their self-identity, rewards were given to them as a token of "**Respect**"(Samman). Child Leaders had done remarkable job

in the way to create awareness among the people of the community. 20 children were facilitated in it.





Social Organizations.

It is an appreciable initiative of Adarsh Seva Sansthan for looking after of the children of single parent or parents (Both) going for work and leaving no one to look after the child. After COVID-19 the Palnaghar was resumed from February 2022. Palnaghar has been used for providing homely atmosphere to the children of working class (Daily Wage Earner) persons or single parent's children. Expenses for the Palnaghar were maintained by the donations from different

# Bridge school Centre

Due to COVID 19 Pandemic many children were drop outs from regular studies. It was rather difficult for them to go for online classes. With the patronage from CRY (Child Right and You) ASES started Four Centers in our working field in Sonari and Kadma Location.

For bridge ups the gap of studies of the children, these centers are being run. It is working successfully and many dropout students get themselves enrolled in regular schools. It is also working very effectively for the enhancement of power of understanding and improvement of level of standard of their studies.

# COVID Relief Program

Awareness creation and Hesitancy clearing-During 3<sup>rd</sup> wave (August 21 to January 22), a survey cum awareness building for vaccination work was done in association with CRY (Child Right and You). During this period we have covered more than 400 house hold and encouraged approximately 3947 people for vaccination. Our activities of



- 1) Small group meetings with community leaders and Basti people
- 2) Organized Street Play for vaccination awareness
- 3) Fixing of Poster on the wall at the prominent location of the Basti
- 4) Attending vaccination camp and persuading people for going to the vaccination centre
- 5) Attending meeting with Anganwadi Sevika and other health worker for information

#### FOOD DISTRIBUTION-

During the PANDEMIC (COVID-19) dry ration were distributed among **133 vulnerable children** and their family members in our working area of **23 slums** of Kadma and sonari and **04**Anganwadi.We have undertaken the work for distribution of Nutritious DRY RATION during the crisis period of COVID-19



# Covid Vaccine Hesitancy Awareness and Vaccination Tracking Programme

**Project Title:** Covid Vaccine Hesitancy Awareness

**Support Organization:** Child Rights & You

**Project Duration:** August 2021 to March 2022

**Overview of the Project:** An earnest initiative had been taken CRY-KOLKATA and ASES JAMSHEDPUR to create awareness of VACCINATION and remove unwanted fear, myth and hesitancy of VACCINATION among the slum dwellers.

Location of Project: 25 slums of Kadma and sonari

## AWARENESS MEETING WITH THE SLUM DWELLERS:

During the campaign period we had meetings with small groups for the awareness creation among the Slum Dwellers. Previously people had wrong conception or myth that had they be taken alcohol "CORONA" would not touch them. Son they had hesitancy in taking vaccine or did not want vaccine. Among the "Adivasi community there was a wrong believe that vaccine may cause "Death". All these points were discussed with details facts and figures and



made them believe that VACCINATION is SAFE and it is necessity for life. In this way we had created awareness among the slum dwellers.

# NETWORKING MEETING WITH HEALTH DEPARTMENT AND AWW:-

A continuous effort had been made and keeping touch with Health Department and AWW for organizing "Vaccination Camp" in slum area wherever it is necessary as per the demand of the slum dwellers. We had a regular consultation with Health Department regarding area, date and time of the slum people for organizing "Camps for vaccination". In this regard we had involved AnganwadiSevika and Sahiya for quick and effective information circulation of message of date and time of the vaccination camp. In this way had achieved maximum output.



### **VACCINATION AWARENESS CAMPAIGN:-**

For the Encouragement creation regarding vaccination, we had organized poster campaign in 20 Slum Basti. During poster campaign we involved Basti Leaders and "Bal Sangathan" for effective response. We had active participation from community leaders and Bal Sangathan also. We had organized "Nukkar Natak" (Street Play) for awareness creation among the slum dwellers. We had organized "Street Play" in 20 Slum areas and got very good response. During the campaign we used Mike and



Loud Speaker for the greater impact from the audience. We also arranged 10 "Nukkar Sabha" (Street Meetings) in different prominent locality of the Slums. With the help of these street meetings, we convey the message that how can a common person overcome the fear of **PANDEMIC** and **safe the life**.

#### REHABILITATION OF 12 CHILDREN-

In the second wave of Corona where the entire state was affected, East Singhbhum district Jamshedpur city was the most affected among all the districts of the state. Among all the zones of Jamshedpur city, Sonari- Kadma (where we have our work area) also had the highest number of positive cases and deaths from corona. During this, 12 such children were identified from the field of work, who had lost either of their parents or both due to corona and other reasons. On June 02, 2021, the information of the case of these children and family was shared with the "Dainik Jagran" press, in the lock down

and treatment of the disease. This news of Adarsh Seva Sansthan was published by Dainik Jagran on 04 June 2021 with the headline "12 children orphaned by corona and other diseases in the city".

This news was tweeted by former MLA of Bahragora Vidhan Sabha, Mr. Kunal Sharangi, along with paper cutting to Union Minister Smt. Smriti Irani, Mr. Hemant Soren (Chief Minister, Government of Jharkhand) and Mr. Suraj Kumar (Deputy Commissioner, East Singhbhum). As a

result, the district administration immediately issued orders to the District Social Welfare Department, Child Welfare Committee, District Child Protection Unit for the rehabilitation of these 12 children with the help of Childline and Adarsh Seva Sansthan, online production of all the children was done in front of the District Child Welfare Committee. These children and their parents will get immediate assistance of 20 thousand under 11 different social



security schemes such as family benefit scheme, sponsorship, Ayushman Bharat, widow pension (to mother), labor card (to mother and guardian), scholarship scheme (labour). Under the card), sports kit, free education support (will bear the full cost of studies), school education kit, food support, production of ration card under Antodaya Anna Yojana etc. Out of these, 03 children and their families were handed over the file related to all the above schemes on 18 June 2021 with the help of Executive Chairman of Jharkhand State Legal Services Authority (Jhalsa) and High Court Judge Aparesh Kumar Singh and District Administration. Under the free education support, an order has been issued by the district administration to the school management to waive all the fees including the school fees of the children.

The Girls First Fund is the first funding partnership of its size focused on ending child marriage with grant making directed to community-based and locally-focused national organizations.

# BAL SANGATHAN (CHILD GROUP) FORMATION AND MEETING

Children Group or Bal Sangathan is formed in 15 slums of our intervention area. Bal Sangathan is the children's platform from which child able to express his or her feeling and problems. Total 25 children group formed 15 girls' group and 10 boys' group. Throughout the year 80 children group meeting conducted in which 430 girls and boys participated in the meeting regularly. Out of 430 children 50 girls and 30 boys



are emerged as Bal Sagathan Leaders. In children group meeting children gained knowledge in many topics, Acts and policies. After coming in Bal Sangathan meetings boys' concentration and positive thinking have increased.

#### LIFE SKILL TRAINING-



Life skills are behaviors that enable individuals to adapt and deal effectively with the demands and challenges of life. Life skills training has led to an increase in the leadership and self-confidence of group mates of girls, boys and also for parents. In this year we organized 50 life skills training with boys, girls and parents in which 337 male and 680 female developed leadership qualities and aware about different issues. Parent has increased sensitivity towards child marriage and child rights issues. They learn and developed self-

confidence to express their views on various platforms. Increased creative thinking and communication skills in girls and increased information on reproductive health, gender inequality. With boys- boy talk module was introduced, aiming to help boys and young people come together, reject conservative ideas and replace them with new ideas/perspectives that they can choose naturally and to helped teenage boys to have their say, feel good about themselves, stay safe and make decisions with information.

#### **SPORTS COMPETITION -**

Sports competition organized for girls and boys to reduce hesitation towards sports, to develop physical, mental and intellectual qualities, to make them responsible and increase their self-confidence. Girls' interest in sports has increased, due to which their hesitation slowing down, as they do not play any games earlier, but now started playing small games in the Basti. Girls came to the field for the first time and get the support of



their parents in this. Children living in the settlement, who were not coming in the children's organization, started participating through sports and awaken the desire to join the children's group.

#### **WOMEN'S SPORTS COMPETITION** -

Women's Sports Competition was organized on the occasion of International Women's Day. Women participated openly in many sports like running, in-out, skipping etc. The women said that "we have participated in sports competition for the first time in our lives; we never got a chance to play". There was a lot of desire from inside but there was shame in playing



due to fear of home, family and society. Women were never allowed to play in society, it was seen very poorly. This has also reduced the hesitation of women and also increased self-confidence.

#### CREATIVE WRITING WORKSHOP-

Two-day creative writing workshop organized to develop writing skill among children. Creative writing is a technique to find inner world and to express oneself more practically and effective way.28 children learned in this workshop. In two days, workshop children able to learn what the process of writing is, what should be collect before starting writing and making it as habit. In this workshop trainer tried to recognize children their potential and hidden quality, so that they can use their time and energy in a



positive way. Few group activities were done and children were given tops to enhance their writing skills. Trainer asked children to write an article everyday on any issue which can enhance their writing skill.

## **WORKSHOP ON CHILD RIGHTS**



Different workshop organized with Bal Sagathan members, leaders and with parents on child rights and child protection issues in their slum area. Children were learned how Child rights came in to force and what are Acts and polices met for the protection of the children. Child rights are the necessary environment and provisions for the overall development of children. The healthy development of children is crucial to the future well-being of any society. Because they are still

developing, children are especially vulnerable – more so than adults – to poor living conditions such as poverty, inadequate health care, nutrition, safe water, housing and environmental pollution etc. Total 70 children and 70 parents learned on these issues through different Workshops.

#### NATIONAL GIRL CHILD DAY

National Girl Child Day is celebrated every year on January 24 across the country. Its objective is to provide maximum support and facilities to the girls of the country in every respect. Apart from this, another objective of National Girl Child Day is to raise awareness about discrimination against girls. It is believed that girls have been facing discrimination and violence in every aspect of life since ancient times. Now, it is time to give them their due rights. The



government of India has brought several acts and made several amendments in the constitution to bring equality in society. This year we have also celebrated national Girl Child Day at ASES Sonari with 35 girls.



# WORKSHOP OF RELIGIOUS LEADERS AND PRI MEMBERS

One day workshop with religious leaders and PRI members organized at hotel Buleward, bistupur with objective to aware them and sensitize them on child marriage act and its provision and to discuss the social and educational aspects of the child marriage with the participants. Role of social media in

increasing cases of Pocso due to child and elope marriage which ruins the future of the society. Religious leaders and Mukhiya ensured us if they came to know about child marriage they will definitely look for this and will try to convince family for not conducting it. Total 35 person participated in the workshop.

## INTERNATIONAL WOMEN'S DAY-

International women's day celebrated at Barmamines with 50 women from different slums. Oriented about the importance of celebrating this day and also from when this day was observing. Success story of American women in the leadership of American Activist Krara Jetali was discussed. Participants were asked to share their views and then are discussed that every



woman's should fight for their rights, as they are deprived and facing lots of issues. Now a day's also in developing country like India women are venerable and should fight against the old rituals and social evils of the society. Every woman should be self-sufficient and should be independent than also they can get equal opportunity in the society.

# YUVA SAMMELAN-

Yuva Sammelan was organized on the occasion of International Women's Day, whose purpose is to develop leadership capacity among girls and to increase information on the issue related to child marriage. In the conference, adolescent girls presented their views in front of government officials, which show an increase in their self-confidence. Drawing competition, slogan competition and cultural



program were organized which led to the develop their talent as well as leadership quality. Adolescent girls from the settlements who have played an important role in connecting children, family and community. Few children were awarded for their work in their respective slums.

Any child and concerned adult can call 1098 and access the CHILDLINE service any time of the day or night. CHILDLINE has the vision to build a Child-friendly nation that guarantees the rights and protection of all children.

Goal: To reach out to every child in need and protection ensure their rights and protection through connect, catalyze, collaborate and communicate to build a child friendly nation.

**Objective:** The major objective of CHILDLINE is to reach out to every child in need of care and protection by responding to emergencies on 1098. To create awareness about CHILDLINE 1098 amongst every Indian child as a reliable source in need is also another objective of CHILDLINE. This program also advocates services for children those are inaccessible or non- existent.

Target Group: 0-18 years of children
