About us

Adarsh Seva Sansthan (ASES) came into existence in 1987 in Jamshedpur's brick kiln areas for ensuring education of children. Brick kiln settlements were established by migrant workers on the banks of the river 'Swarnrekha' and 'Kharkai'. Slums in Jamshedpur (Jharkhand) are situated on the periphery of the planned city. Although hutments are now semi-permanent, there is no recognition of these residents in larger urban development planning programs.

ASES started operation for the development of slum children as most of the children were malnourished, suffer health problem due to environmental changes and didn't attend school. In order to educate the slum children, ASES started working in slums by starting Non-Formal Education School (NFES) comprising of 45 children in NTT basti, Jamshedpur. Gradually NFES in nearby basti followed. The year 1995-96 was a turning point for the workers as the lease of the brick kiln factories expired and was not renewed owing to environmental concerns. As a result, the brick kiln factories were closed. The migrated workers however continued to live in these settlements which are currently situated in different parts of Jamshedpur which is part of the TATA Lease Agreement.

Children, Men and Women are empowered through Bal Sangathan (Children Collectives), Joint Basti Committee (Community Based Organization) and Mahila Mandal (SHGs) which is Strength of ASES. ASES's welfare initiatives address core issues on Human Right, Child rights, Women's empowerment, Environment, Education, Crèche (Palnaghar), and Advocacy

MAJOR ACTIVITIES LEADERSHIP OF BAAL SANGATHAN

- When schools opened after Covid, "Back to School" campaign was run. Under which regular monitoring of school going children had been done. Due to which the attendance rate of children in the school had done up to 80%
- Identification of 'Out of School', 'Drop-Out', 'Child Labor' children from Basti (Slum)
- To move the cases of child marriage to the child line or organization (ASES) or file a case.
- Survey of status of social security scheme in 6 Basti
- An **Awareness Campaign** had been conducted in the community on "Child Marriage" and "Child Labor" from 05th to 16th October 2022. Under this, "Wall Writing", "Awareness Rally", "Painting and Writing" Competition, "Folk Dance" competition and "Football & Kabaddi" tournament had been organized.

BAAL SANGATHAN (CHILDREN'S COLLECTIVE) MEETING



This is the main activity of 26 children's collective formed in 23 slums of Jamshedpur. These meetings used to be held rather weekly or monthly or the day fixed by each children's collective. These meetings are conducted under the leadership of children's collective (Baal Sangathan) leaders, in which child issues of the slum (Basti) are discussed and decisions are taken accordingly.

A total of **157** children's collective (Baal Sangathan) meeting held this year. The main issues of these meetings were Enrolment of out of School Children;

Drop Out, Child Labour and Child Marriage.

BAAL SANGATHAN (CHILDREN'S COLLECTIVE) LEADERS' MEETING

Two half-yearly meetings have to be held with the leaders of 26 children's collective. In the first half yearly meeting, the action plan of the children's collective was prepared and its responsibility was fixed. In the second half yearly meeting, the work of the children's collective was evaluated and the future action plan was prepared.



BAAL SAMMELAN



BAAL SAMMELAN is an annual conference of 26 children's collective (BAAL SANGATHAN) formed in 23 basties. 400-500 members from all children collective participate and discuss serious child issues of the basti. About 250 child leaders from all 26 baal sangathan participated in the BAAL SAMMELAN 2022. In the year 2022, the works and achievements done by baal sangathan on child issues were reviewed.

55 Child leaders were recognized on the achievements of the Baal Sangathan.

ENROLMENT CAMPAIGN

An Admission Campaign was launched in association with the children's collective at the community level for the enrolment of 'Out of School' and 'Drop-Out' children in the school. Under which the children's collective made a list of children out of school from their respective Slums. Based on that list, meetings were held with various stakeholders in the Basti (Slum) where a large number of children were found out of school. In



which children identified out of the school, their Parents, Anganwadi Workers, Basti / Women Leaders, Teachers / SMC members and members of the Baal Sangathan participated. In this meeting, children and their parents were motivated to enroll their child in the school and the admission strategy was prepared.

These special meetings were held at New Kapali Basti, Bacha Singh Basti, Balram Basti, Siddu-Kanhu Basti Zone-1, Birsa Basti, Baba Tilka Majhi Basti and U.M.S. Bhatia Basti Kadma. After this, a total of 25 (12M, 13F) age group of 6-14 years and 05 (01M, 03F) age group of 15-18 years "Drop Out" children were ensured admission in various government schools.

In this academic session, a total of 52 (30M, 22F) Un-Enrolled Children of 6-14 years and a total of 67 (36M, 31F) of 6-14 years and a total of 06 (02M, 04F) of 15-18 years children's Re-Admission were ensured in the school.

RTE ADMISSION: -



Under the RTE Act, special initiatives were taken to enroll poor children in English Medium Schools. Under this initiative, about 35-40 eligible children from the Basti (Slum) were identified and held a meeting with their parents and they were given complete information about this Act and they were told to prepare the necessary documents related to admission. Along with this, assistance was provided to them by being in constant touch with the family members in the preparation of necessary documents including Forms submission, Birth Certificate, Income

Certificate, and Ration Card.

As a result of this initiative, a total of 06 (05M, 01F) children were ensured admission in various English Medium Schools.

LIFE SKILL SESSION AND LEADERSHIP DEVELOPMENT TRAINING

Various Life Skills sessions were organized among the children of the children's collective (Baal Sangathan) to develop the necessary qualities / characteristics like Capacity Development, Knowledge Building and build up Self-Esteem among the children. Various "Boy-Talk" sessions were conducted, especially among teenagers/boys. Through life skill sessions and "Boy-Talk", children get an opportunity to understand themselves amidst the surrounding environment.



Along with all this, training and various activities were also been organized for Leadership Development of the leaders of the Children's Collective (Baal Sangathan). So that the Children's Collective can create better plans for themselves and for the development of all the children in the community.

EXPOSURE VISIT OF BAAL SANGATHAN LEADERS



Exposure visit is a part of the Capacity Building of the baal sangathan. The local police station (Baal Mitra police station Sonari & Kadma) and the district government hospital (MGM Hospital, Jamshedpur) were visited by the Baal Sangathan leaders and information about the services to be provided there was also given. Children also increased their knowledge by asking questions.

VISIT OF TIMKEN FOUNDATION



On 19th of March'2023, the team headed by Mr Henry (Kurt) Timken, The Treasurer of Timken Foundation had visited the slums of Soanari, Jamshedpur. He accompanied by Mr Sanjay Kaul, the President South East Asia, Chairman, and Managing Director Timken India, and a high-level delegation, had visited at proposed project location Anganwadi Centre of "New Kapali Basti" and New Construct Anganwadi Center, Balram Basti, Sonari, Jamshedpur.

FLOOD RELIEF WORK



Due to downpour on August 19-20, 2022 in Jamshedpur, had increased the water level of two major rivers of Jamshedpur, 'Swarnarekha' and 'Kharkai'. Hundreds of houses situated in the slum area of Sonari-Kadama on the river bank of Swarnarekha' and 'Kharkai', were affected by the heavy floods caused by the rains and river water. Bastis was submerged in flood water for two days i.e., 20^{th} to 21^{st} of August 2022. As a result, hundreds of houses (about 800 houses) suffered economic loses like ration, clothes, beds, utensils, books, copies, etc. Many houses badly damaged due to

food.

Adarsh Seva Sansthan, in collaboration with CRY (Child Right and You) in 23 Slums situated on the river bank of Kadama-Sonari area of Jamshedpur, provided 'support to the Sanstha (ASES) in the form of a one-time grant for 'Relief Work' of flood victims. Under which 'Ration Materials', 'Sanitization kits', 'Bed-Sheet', 'Utensils' etc. had been given for distribution as relief material to the flood victims. On the basis of the grant received, Ration Materials had been distributed among the 200 severely affected families, sanitization kits to 100 families and utensils and beds to 94 families. Apart from this, 10 such families were identified whose houses were completely or partially damaged due to floods. Tarpaulins were provided to such families.

POWER OF CHANGE (CASE STORIES)

On 5th of August 2022, **International Youth Day** was celebrated with "**Powerful Youth**" who were recognized for their contribution in **SOCIAL CHANGE**. A virtual meeting was organized by **Child Right and You** (CRY-AM) on Zoom platform. Six candidates were selected from all over India to share



their "Transformational-Journey" with all of us. "Ilma Afroz" – (SP SDRF, IPS Officer), "Abhir Bhalla" (Young Environmentalist), "Shrawni Ojha" (Advisor of NGO-"Save the Children"), "Amit Jain" (Co-founder off NGO-"Mitti K Rang"), "Lucky Sonkar" (Child Champion), and "Sushmita Kumari"-(Child Champion) among the selected speaker.

Sushmita Kumari despite of so many hurdles came from the family and surrounding community, Susmita able to convince her parents and continued her studies and passed the 10th Examination successfully. She also inspired other fellow students to overcome the hurdles and continue their studies.

The Girls First Fund is the first funding partnership of its size focused on ending child marriage with grant making directed to community-based and locally-focused national organizations.

BAL SANGATHAN MEETING



To strengthen and activate the girls' children group in 15 settlements, the children group of 14 settlements are being led by girls. Due to this, a lot of change is visible in them like their ability to communicate their issues and problems. Girls are started discussing issues like child marriage, drop out as well as gender inequality, reproductive and sexual health rights. This year 71 meeting conducted in which 901 girls and 408 boys participated. 70 boys and 450 girls have emerged as members in the children group.

18 girls and 5 boys who have chosen their partner, but they were prevented from elopement with their boyfriend through several counselling session.

LIFE SKILL TRAINING-

This year 11 life skill training organized this year with 181 girls and 50 boys. with objective to impart knowledge on different topics like child marriage, its adverse effect, understanding child rights, different policies and acts. Though life skill training girls and boys were become mentally strong and able to learn the ways of daily life. They will become adaptable and positive by being able to learn and prepare for challenges, risks and difficult situations. Child were trained on WHO's 10



life skill modules and able to cope up with the day-to-day challenges and difficulties

Through this training, 432 girls are being able learn how to overcome from the challenges of daily life. They also understood about their rights and able to establish effective communication with the concerned officials - like Block Development Officer and MP.

Out of 20 drop out girls and boys, 4 were re-joined the school. The enrolment process of remaining children is going on. Friends of the children group played an important role in this entire process. 26 children were newly enrolled. This year, 10 girls have passed the 10th class examination in first division and 9 girls have passed with first division in the 12th class examination.

DANCE THERAPY-



Dance Therapy is conducted on 24.04.22 with boys to increase confidence, self-esteem and reduce anxiety and depression. Resource person shared that dance can be the road of healing, our human body always express itself, store information and memory and event we went through in our cells and dance and moving is able to clean the rocks that obstacles the way of the energy flow. Dance is able to move these information rocks away and to create new relationships, new ties. Children enjoy a lot in the

session.

NUKAD NATAK TRAINING

Two days Two Nukad Natak training organised at in this year one at Mahila Kalyan Samittee with 23 girls and another at Community Center, Chunna Bhhata with 46 boys and girls. The resource person Mr Goutam Gope and Vikram Jha has lots of experience in the street play. The objective of the training is to develop self-confidence and leadership quality among them through street theatre. For better understanding trainer conducted various games and role play activities. The trainer shared stories on child



marriage and asked the children to form a play on that story. The children tried their best and presented the story in a very beautiful manner.

ADMISSION DRIVE RALLY



In 12 basti of Kadma, Sonari and Barmamines with 334 children to aware about the importance of education and identify drop out children with the help of community and parents. Bal sagathan leaders and member themselves taken initiative to organised the rally in their respective

POINT OF VIEW CAMPAIGN-

20 Girls (Bal Sangathan members) were given Nukar Natak performance in 6 basti namely Adarsh Nagar, Janta Basti, jakir bhata, Tina Kholi, Chunna Bhata, and Vinoba Ashram on child marriage. This campaign name was "Udaan- Meri Sapno ki Udan Ashma Tak" Girls enjoyed a lot while performing and moving with team to one basti to another. More than 500 people aware about the issue and appreciated the efforts of team and girl's.



EXPOSURE VISIT

On 29-06-22, an exposure visit of active women of the field was conducted. The main objective of this program is "to develop leadership quality among them and to increase knowledge about various department and to make understanding to avail benefits from that department or office.



<u>ANNUAL MEET OF BAL SAGATHAN</u>



With 2nd line leaders

Two days Annual meet organized with New Bal Sangathan leaders on 22nd July and 23rd July 2022, at 10th miles stone with 40 children. The objective of the program is to develop leadership quality in the new members of Bal Sangathan and to increase interest in activities of organization.

With girl's Bal Sanagthan Leaders-

Two days annual meet of Bal Sangathan girl's leader organized on 1st & 2nd June 2022 at 10th miles stone with objective to develop understanding of girls about leadership qualities as all of them are leader or representative of their respective basti. They have to pursue some qualities and should have understanding about the role and responsibility of a good leader. Art and craft session also conducted in this meet to develop creative thinking among them total 27 girls participated in this meet.



With boy's Bal Sagathan Leaders-



Two days annual meet of Bal Sanagathan boys' leaders organized at 10th Miles Stone Mangao on 25th & 26th June. In this annual meet 40 Bal Sanagthan leader were participated in this training. The objective of the annual meet is to review of their work throughout the year and to understand issue related to child marriage & child protection and to solve their issues. Few sessions on boy talk also organized in this meet with purpose is to bring boys and young men

together and help them reject stereotypes and instead adopted

new ideas/views that they can naturally pick up.

WORKSHOP WITH PARENTS ON CHILD MARRIAGE

One day workshop had been conducted on 9.07.22 at hotel Boulevard Bistupur, with parents on child marriage 39 women has been participated in the programme. In this workshop discussed about the child marriage act and its provisions. In this workshop we encouraged parents about their right to have equal position in family along with male person for taking decision for their children's future. What are the



disadvantages of child marriage and is it good for their children. Few case studies and short films were shown to them. Encouraged parents and asked them not to stop their children and to know their equal right for the decision making of the future of their child. And requested them to let their children fly in the open air as Child marriage is like a cage. The participants said that they will neither try to arrange their children wedding nor want to go to the jail.

WORKSHOP ON CHILD MARRIAGE WITH TEACHER'S -



Two days' Workshop was organized at Buleward Hotel, Bistupur the issue of child marriage with KGBV teachers. In this workshop total 70 teachers were participated. Teachers play an important role in building a child marriage free society and how a teacher contributes in; it was discussed in this workshop. Mr. Shyam Sunder Mallick given Information about the child marriage law and discussed how we will eliminate challenges of going

minor boys and girls going with their favourite partner. Mr

Kamal Kishor, DSP-2 Cum SJPU asked teacher's that when the teacher comes to know that a girl in their school is going to get married, they should inform concerned officer or departments; so that it will be easy or help full to the concern department and they can protect that girl child. it was also discussed further in the session that even after marriage also girls and young women could go to school, they should also get a chance to study in residential school. Teachers were very helpful in the enrolment of drop-out and enrolled children.

ONE DAY WORKSHOP ON CHILD MARRIAGE AND CHILD RELATED LAW AND ACTS WITH BAL SAGATHAN LEADERS

On 09.08.23 one day workshop Organized at Zoological Park of Jubilee Park, Sakchi with 38 Bal Sanagathan leaders from different slums of Kadma, Sonari and Barmamines and Adarsh Seva Sansthan Staff to aware them on different child related laws



and policies and made them capacitated on it. Bal Sangathan leaders are the pillar of our organization, as the part of Basti and also as leaders they should know about the Acts and laws which belong to them and they can aware others and spread knowledge to others. Mr. Piyusha Sengupta and Niraj Kumar explained about JJ Act, Child marriage Act, Child Labour Act and POCSO Act.

ANNUAL SPORTS-

On 28.08.23 and 4.02.23 annual sports competition organized at Inder Singh basti Barmamines and Jakir Bhatta, kadma with 170 Bal Sangathan members and leaders from 10 basties of barmamines and 3 basti of Kadma. With objective to increase physical, mental and intellectual development of Adolescent girls and boys. Also, to increase their interest in sports, as in slums because of lack of space for playground children are not playing any



physical games like football, cricket, Kabadi etc. Annual sports of boys and girls began the new chapter for girls to play in slums and its acceptance. It helped to develop a positive attitude of the Basti-Committee and Mahila Mandal towards girls' sports and they are allowing their daughters to participate in the sports competition. Girls started playing small games in their basti like badminton, Ludo, Kho-Kho, Kabaddi etc.

CREATIVE WRITING WORKSHOP-

creative writing workshop organised with bal Sangathan leaders on two different topics one is content making, story & news writing, report making and another is drawing characters and making story with it. On 10.09.22 first workshop organised at Hotel Boulevard, Bistupur with 32 (Boys & girls) Bal Sangathan leaders. FLOOD RELIEF WORK



Due to heavy (270 mm) rainfall on 19-20 August 2022, the water level of two major rivers of Jamshedpur, Swarnrekha and Kharkhai increased and hundreds of houses in the slums situated on the river banks of Sonari-Kadma were badly affected by the severe floods caused by rain and river water. Settlements remained submerged in flood water for 2 days on 20-21 August 2022. As a result, hundreds of houses suffered financial loss (ration, clothes, bedding, utensils, books-copies etc.).

Many houses in two settlements of our Kadma area, Zakir Bhatta and New Shyam Nagar, also got hit by floods entered. Due to water remaining inside the house for two days, the condition of the house became quite pathetic. Adarsh Seva Sansthan, in collaboration with GFF project, distributed ration material, sanitization kit, mats and educational material to children as relief material to 70 families.

EDUCATIONAL TOUR CUM EXPOSURE VISIT

On 18th and 19th Two days Educational Tour cum Exposure visit organized at Ambadubi Tourist center Dhalbhumgarh to 30 girls with objective to make the adolescent girls interact directly with the concerned stakeholders and public representatives and to develop their leadership abilities by promoting their right to expression and participation and to make them aware of the history



of Dhalbhum sub-division by visiting its historical heritage sites. Mr. Vidhyut Varn Mahato, MP Jamsedpur came to visit children and children shared their basti issues with him and he ensured and asked children to come to his office with their parents so that they can able to solve their problem.
